SALE AGREEMENT

- 1. I understand that when my livestock project is sold, there will be charges deducted from my check, including a 3% commission fee and species specific fees/assessments as mandated.
2. I understand that all beef, sheep, goat, feeder calf and swine consigned to the sale will be processed by the IV Fairgrounds. I understand this is a terminal sale and there is no custom processing of animals.
3. I understand that the sale of my market animal project is contingent upon a health check and weight requirements. If my animal is deemed not ready, I will not be able to participate in the Grading Show and my animal must be removed from the fairgrounds immediately. If my animal fails inspection, I also understand I will not be included in any online add-on process by IV Fairgrounds.
4. I understand that I must follow all my organizations (4-H, Grange or FFA) requirements to participate in the Grading Show.
5. To participate in the Online Add-Ons, I understand that it is mandatory to show my project and follow the rules of the scheduled Livestock Grading Show.
6. I understand that I will do my best to encourage community members to participate in the IV Fairgrounds Online Add-Ons to monetarily contribute to my livestock project.
7. I understand that any online add-ons which have not been paid by the May 1, 2021 deadline will be removed from sale and I will only be issued a check for the market value of the animal and all paid add-ons, subject to and all applicable deductions for fees/assessments. I understand and agree that the check issued after the May 1, 2021 deadline constitutes the full and final amount from the IV Fairgrounds for the sale of my livestock project, and waive any right to payment from the IV Fairgrounds for any online add-ons not paid by any buyer by the May 1, 2021 deadline.

DRUG STATEMENT:
